### **Registration Rules**

Registration for the Vo Vi convention on a cruise ship differs from registering on land. The cruise company can increase their prices at any time, and the closer to departure date, cabin prices may increase depending on the occupancy rate. Therefore, we would advise that you register as soon as possible to be able to select your choice of cabin and maintain the cabin price. If your selected cabin is no longer available, we can request additional cabins, but prices could change.

### **Cancellation Rules**

In case you cancel:

- Before **1st September 2013**, you will get 100% refund with the following condition:  
We have to cancel all persons in the same cabin. If you only cancel one person in the cabin, the remaining people must pay for the difference in fares. For example, 3 people in a triple cabin who cancel one person will have to pay the cruise fare for a double cabin, etc.
- From **1st September 2013** to **1st October 2013**, you will get a refund less 450 USD penalty.
- From **1st October 2013** to **1st November 2013**, you will get 50% refund.
- From **1st November 2013** to **15 November 2013**, you will get 25% refund.
- After **15 November 2013**, there will be no refund.

### **Fees to change names or type of cabin:**

There is a 25 USD fee each time you request to change names in a cabin, or to change to a different type of cabin after registration.
